TERMS AND CONDITIONS

Application for participation is to be made in prescribed form. Acceptance and exhibits will be at the organizers.

- Stalls will be allotted on a first come basis only on receipt of completed application form along with requisite payment
- Allotment of stalls will be made at the discretion of the organizers
- Subletting of stalls or displaying products not covered by original application will not be allowed

STALL ALTERATION

- No alteration of size and position of the exhibitors stall is permitted without the prior written approval of the organizers.
- The organizers reserve the right to modify the layouts and gangways
- The organizers reserve the right to request the exhibitors to make such alteration of their stalls as to setting of exhibits as they reasonably feel necessary to maintain an acceptable standard of presentation or to avoid interference with the display of the other exhibitors
- Conversion of the allocated shell scheme site to free design is not permitted.
- While reasonable fixings may be made to the flush plywood walls of the shell scheme at the expense of the exhibitor or his agent, no major alterations will be permitted.
- Stalls may not overhang the allotted area, nor any obstruction will be permitted on gangways, fire points, extinguishers or emergency exit.

STALL INTERIORS

- While the exhibitors are free to decorate their stalls they should not cause any permanent damages to the walls, panels and floor through use of nails, painting or any such activity.

DEFAULT ON PAYMENT

- The organizers reserve the right to cancel any reservations of space in the event of an exhibitor not having paid the dues of rental charges as stipulated in the brochure. Payments already received will be forfeited in such cases.

POSSESSION OF STALL RIES

- Possession of stall will be given only on receipt of full payment including payment for extra requirements.

SPACE NOT OCCUPIED

- Every exhibitor shall occupy the full stall area booked
- Should exhibitors fail to take the stall allocated to him, organizers reserve the right to deal with the stall so unoccupied as they think appropriate.

NO SUB-LETTING

- The exhibitors may not assign, sub-let or grant license of the whole or any part of the stall.
- Cards, advertisements or printed matter of persons or firms that are not bonfire exhibitors will not be exhibited or distributed from any stall except on exhibitor may distribute cards, advertisement or printed matter in respect of companies or firms which are subsidiaries of exhibitors ultimate holding company

OPERATION OF STALL

- No stall will be left unattended during the exhibition. Stall of exhibitors must be present at least one hour before the opening and half an hour after the closing time of exhibition
- No activity, which in opinion of organizers, amounts to nuisances or annoyance will be caused by the exhibitors. The organizers shall have the right to take remedial action in such cases.

VACATION OF SPACE

- Space will have to be vacated by 9 pm on the last day of the exhibition, failing which the exhibitor will be required to pay a penalty as prescribed by the organizers and they will have the right to remove the exhibits, materials etc., of exhibitors, at the risk and cost of exhibitors

SECURITY

Although 24 hour security service will be in operation throughout the exhibition, exhibitors should take all possible precautions to minimize loss or damage to the equipment outside of exhibitions timings.

ELECTRICAL INSTALLATION

All on-site electrical installation must be carried out by the officially appointed electrical contractor before connection to the main supply.

INSURANCE

Insurance of the exhibits and the property of the stalls will be the responsibility of the individual exhibitors. The organiser shall not be responsible in anyway for personal injury to the exhibitor or his staff, invitees or licenses, however caused.

FAILURE OF SERVICE

The organisers will use their best endeavours to ensure supply or services of the hall and official contractors, but as the supply of such services are not within the control of hall and contractors, neither they nor the organisers shall incur any liability to the exhibitors for any loss or damage, if any service shall wholly or partly fail cease to be available. Nor shall the exhibitor be entitled to any allowance in respect of rental due or paid under the contract

CONSEQUENTIAL LOSS

In case of the exhibition being cancelled or suspended in whole or in part for causes not in the organisers control, the organisers do not accept any consequential liability to retain the right to change the exhibition dates/venues or cancel the exhibition if in their opinion there is necessary cause for the same

INTERPRETATION

The decision of the organizers or nominee shall be final and binding on the exhibitor on the interpretation of rules and regulations.

Rights
